Processing Statement

The film properties have been measured on 25 µm thick films (Blow-up ratio: 2.5:1).

Processing Conditions

- Screw speed = 60–85% of maximum.
- BUR = 2.5:1 to 3:1.
- Temperature setting from 195°C - 205°C.

Notes:

Availability:

This product is supplied in 25 kg bags in secured pallets of 60 bags (1.500 MT net). It is also supplied in jumbo bags of 1000 kg capacity.

Storage:
